REGULAR MEETING  
MINUTES

The Muskogee Board of County Commissioners met in session at 8:15 a.m. Members present were: Chairman, Keith Hyslop; ~~Vice Chairman, Kenny Payne~~; Member Ken Doke; and Muskogee County Clerk, Polly Irving.

**1: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved to Open the meeting at 8:30 a.m. The motion was unanimous.

**2: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved the Purchase Orders. The motion was unanimous.

**3: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved the Monthly reports. The motion was unanimous.

**4: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved Regular meeting minutes for December 29, 2025 after revisions were made. The motion was unanimous.

**5: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved an Information Sheet from Boynton Volunteer Fire Department for the calendar year 2026. The motion was unanimous.

**6: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved the Amended 6-Month Bid list that added a company that had done everything ahead of the deadline. **County Clerk, Polly Irving:** *"On the outside of the envelope, it actually had 400 West Broadway. It was the date stamped from the post office way ahead of time. And for some reason, somehow, it got taken to the City of Muskogee. And City of Muskogee marked through our address, and they actually stamped it also, which still was before the due date here. But I didn't get it to until way afterwards."* **John Tyler Hammons:** *"So we determined that the bunch for the postman's area would have been properly delivered, so it is proper for you all to accept it to amend the six-month bid list."* **Commissioner Doke:** *"Okay. Just one legal clarification here. So originally, because I had a conflict of interest, I didn't vote on the six-month bid, but this is not tied to me in any way, so I'm okay to vote on the amendment?"* **John Tyler Hammons:** *"Yes, sir. Because you're just amending to add to this one thing that had the postman done his job as he should have done his job, we would have had him."* The motion was unanimous.

**7: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved a Resolution for Disposal of Equipment from the County Clerk's Office. The motion was unanimous.

**BIDS:**

**Bid 2025-040 – Locks/Intercom @ Muskogee County Jail**

*All bids were closed at 9:00 a.m.*

**Motion:**

Commissioner Doke made a motion and it was seconded by Commissioner Hyslop, approved and awarded Bid 2025-040 – Locks/Intercoms at the Muskogee County Jail to Sydaptic, Inc not to exceed \$76,000 utilizing the Use Tax Fund. **Commissioner Doke:** *"Greg, you probably talked to these people, right?"* **Greg Martin:** *"Yes, I have. I mean, that's something I've been in the*

works with for quite some time." **Commissioner Doke:** "So, one thing I have learned about detention locks and things like that is that they're pretty specialized. And it's not something that there's just a million vendors out there to do. And so, I'm not surprised that we only have like one bid on these types of things. Because we've had to deal with locks for the juvenile detention center and things like that. And so, there are rules, I guess, on what kind of locks you can put in and things like that, I guess." **Greg Martin:** "I understand that the adaptors we've had with that system, if you do the system from ground up, it will be very, very, very expensive. A number that I wasn't comfortable with at all. It's just starting from ground up, basically. So, this is the servicing we take care of it going forward." **Commissioner Doke:** "So, it looks like on the replacement limit switches and ten new detention locks for repairs, reason for limiting replacement locks for the overall cost for each lock, \$3,276 each. And then a list of preventative maintenance that they would do. It says, while on-site, Sydaptic will have 20 replacement intercoms, should any need replacing, and we will incorporate the utilities back into the security control system. Estimated price for the proposed repairs are \$76,000. So, is this pretty open-ended, like \$76,000, but it could be more if they have to do intercoms, or is it \$76,000 at the top?" **Greg Martin:** "Not to exceed that amount. If something goes over that amount, then we'll have to revisit and come back." **Commissioner Doke:** "Yes, as many cable or wiring needs replaced, there could be additional charges. Prices are for 10 replacement locks, 20 intercoms. So, it doesn't look like the intercoms are included in the biggest." The motion was unanimous.
