The Muskogee Board of County Commissioners met in session at 8:15 a.m. Members present were: Chairman, Keith Hyslop; Vice-Chairman, Kenny Payne; Member Ken Doke; and Muskogee County Clerk, Polly Irving.

1: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved to Open the meeting at 8:21 a.m. The motion was unanimous.

2: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved the Purchase Orders. The motion was unanimous.

3: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved the Monthly reports. The motion was unanimous.

4: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved Regular meeting minutes for June 8, 2026. The motion was unanimous.

5: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved a Declaration of Surplus (2026-17) for District 2. The motion was unanimous.

6: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved a Resolution for Disposing of Equipment (2026-16) for District 2. The motion was unanimous.

7: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved a FY26-27 Officer List for District 2. The motion was unanimous.

8: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved a Pay Application #7 for the Okay Road Project. **Brian DeShazo:** *"This is just our monthly pay application from the contractor, APAC, for the OK Road project. We've had a few weather days and so it's only about \$85,000 for that one. Kevin's been working to get our reimbursements back from ODOT so we can recapture some of our funds, but this won't be paid until we receive funding in our special account there. So, this is just pre-approval."* **Commissioner Doke:** *"Again, this is not actually paying it. This is just approving it to send it up to commerce."* The motion was unanimous.

9: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved an Application and Utility Permit (2026-14) from Lake Region Technology & Communications, LLC to maintain an underground fiber optic cable at 1506 Bowden Place, Fort Gibson, OK located in District 1. The motion was unanimous.

10: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved a FY26-27 Inventory List for General Government. The motion was unanimous.

11: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved a FY26-27 Inventory List for District 2. The motion was unanimous.

12: Motion

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved an ACCO-SIF 2026-2027 Workman’s Comp Renewal Quote and chose option 1 for the full payment amount of \$244,861 which was an increase from last year by approximately \$2,500. The motion was unanimous.

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved a 2026-2027 Annual Renewal Contract with Comanche County Regional Juvenile Detention Center (CCRJDC) for Juvenile Detention Center services at the price of \$69 per day. The motion was unanimous.
