1: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved to Open the meeting at 8:23 p.m. The motion was unanimous.

Sometimes through dispatching, whether it be our county or their county, I'm not going to get into the semantics of it, but there might be, say, a car crash a mile into McIntosh County past the county line. We're a mile and a half from it. Their closest fire department is 18 minutes from it, yet they get dispatched and we don't. So, we're trying to, I think the name of the game should be public safety. I think that's why we're here in the first place. And that's what we're trying to achieve here. So, the next several items on here are going to be automatic aid agreements. And by automatic, there's mutual aid, which means if they need you, they'll call you. There's automatic aid, which means if there's something in that area, you get called and then you and the other jurisdiction decide whether you're needed there or not, but you get the call. And that's what we're trying to achieve through all this. And, like I said, there are four or five on here, but in that vein, I'll move for approval on this item."* The motion was unanimous.
