REGULAR MEETING
MINUTES

The Muskogee Board of County Commissioners met in session at 8:15 a.m. Members present were: Chairman, Ken Doke; Vice-Chairman, Keith Hyslop; Member Kenny Payne; and Muskogee County Clerk, Polly Irving.

1: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved to Open the meeting at 8:49 a.m. The motion was unanimous.

2: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved the Purchase Orders. The motion was unanimous.

3: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved the Monthly reports. The motion was unanimous.

4: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved Regular meeting minutes for October 20, 2025. The motion was unanimous.

5: No Action

No action was taken regarding an advisory working group on permit to make recommendations on the new county permitting process.

6: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved an Invoice from Five Star Demolition in the amount of \$39,915 for the building pad demo at 525 W Okmulgee to be paid back to the county out of Use Tax. The motion was unanimous.

7: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved the 2026 Calendar Year of Regular Scheduled Board of County Commissioners meetings. The motion was unanimous.

8: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved a Proposal from Sligar Mechanical to repair the boiler control panel at the county services building in the amount of \$5,804. The motion was unanimous.

9: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Doke, approved a Project Agreement between Muskogee County and the Oklahoma Department of Transportation for the construction of a lake access road project (State Project No. SAP-251D, 194 LG). The motion was unanimous.

10: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved a Canadian County Juvenile Detention Center Contract for the 2025-2026 fiscal year at a cost of \$36 per child per day. The motion was unanimous.

11: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved a Change Order number 1 for the Okay Road Project. Commissioner Doke explains: *"Brian put this on, but per the request of APAC, which is the awarded contractor on it and approval by*

Oklahoma Department of Commerce, basically we're having to shut the road down to do the road work and there was only one message board included on it and they wanted a message board on both ends. And so this looks like the change order is for \$16,000. It'd be for a message board throughout the remainder of the project is my understanding. So that'd be paid for out of grant funds." The motion was unanimous.

12: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved an Agreement between the Board of County Commissioners and Eventus, Inc b/d/a CB Roofing who was awarded Bid 2025-036 – Courthouse Roof Improvement Project in the amount of \$128,575 utilizing the Courthouse Improvement Fund. The motion was unanimous.
