District 1 will front and pay all project costs directly, and upon completion, Cherokee Nation will reimburse District 1 directly for project costs up to the total grant amount, not to exceed \$150,000. The motion was unanimous.

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved a Memorandum of Understanding (MOU) between Muskogee County District 1 and the Town of Fort Gibson regarding the construction and completion of road improvements in the Saddlebrook Addition. Upon completion, Fort Gibson will reimburse District 1 \$25,000 for project costs. The motion was unanimous.
