That Muskogee City-County Port Authority, P.O. Box 2819 City of Muskogee, Muskogee County, State of Oklahoma, hereinafter called the Grantors (whether one or more), for and in consideration of the sum of one dollar (\$1.00) and other good, valuable and sufficient considerations, do hereby grant, bargain, sell, convey and dedicate unto the County of Muskogee hereinafter called the Grantee, a perpetual easement over, under, and across the following described lots or parcels of land, to-wit:
