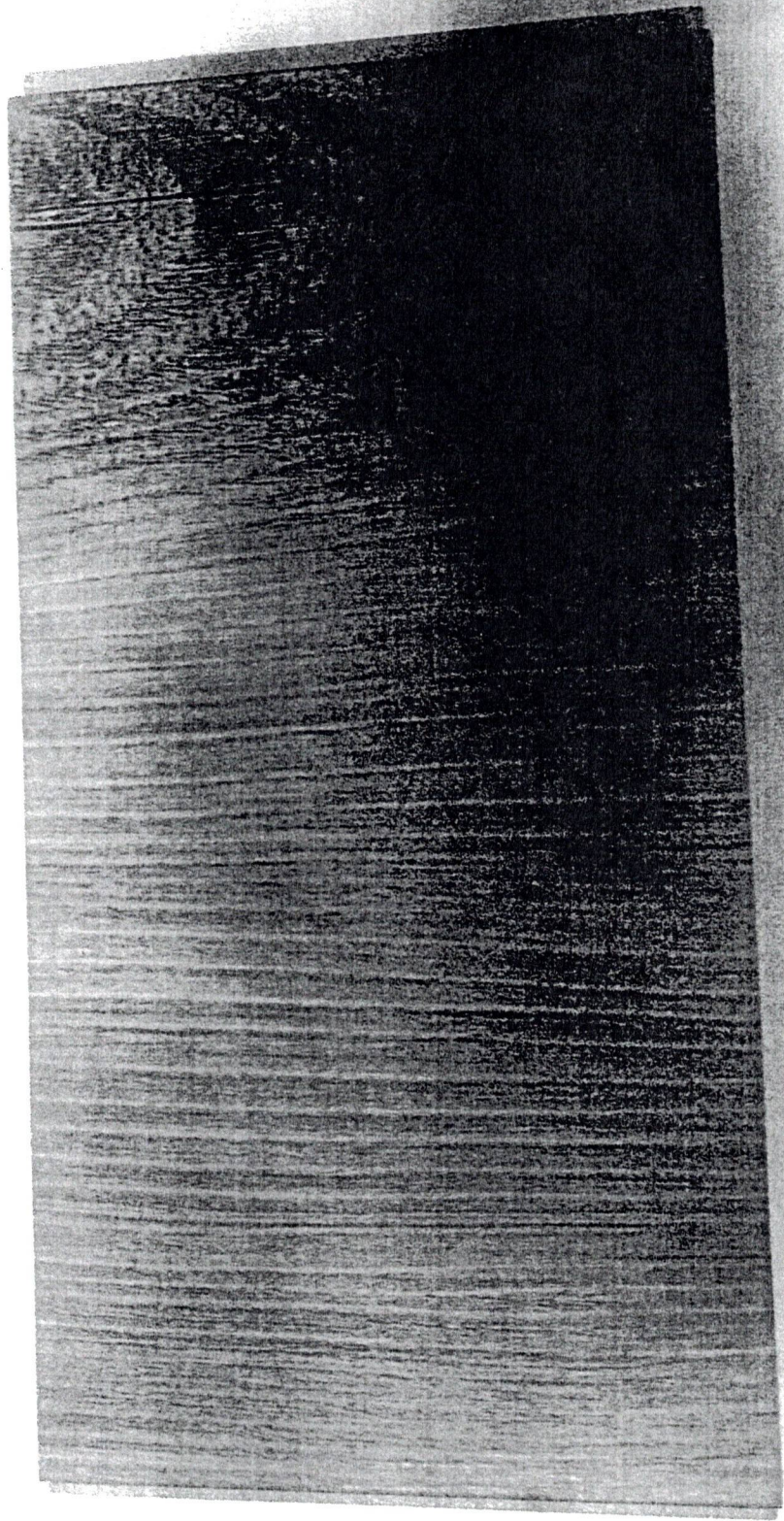
*A/C purchase and install mini split AC/Heat unit in North office.
