# HASKELL VOLUNTEER FIRE DEPT. WILDLAND BRUSH/FIRST ATTACK FIRE APPARATUS BLANCHAT MFG., INC. July 31, 2023

#### **MINIMUM SPECIFICATIONS**

The following specifications are to provide for a custom-built Wildland Brush/First Attack Fire Apparatus to be installed by the manufacturer on a 2023 Ford F350 Ext. Cab, Gas,4 x 4, regular chassis cab with 60 inches cab to axle, single rear wheel with a 11,300 GVW rating, that is to be supplied by HASKELL FIRE DEPARTMENT. The custom-built service maintenance type body shall be fabricated from heavy channel iron frame, 12-gauge premium sheet steel with welded seams. The overall bed dimensions to be 96 inches by approximately 115 inches long, with a load ground clearance of 26 inches from the bottom of the apparatus to the ground.

#### **FRAME**

There is to be no exception to the frame material (steel only ~ NO aluminum). Aluminum style bed will jeopardize the integrity of the steel body frame design. The uni-structured body/frame design allows the ATROPS (Apparatus Transverse Rollover Protection System) to be incorporated using six (6) sides of steel protection.

The long sills in the apparatus frame (main stringers) will be constructed from 6-inch 9 lb. per foot steel channel. When possible, full-length channels are to be used and steel cross channels (3-inches) are to be securely welded in place using fabrication devices for accuracy.

The frame design will be welded to allow the lowest center of gravity possible for the tank. The tank will be recessed into the deck of the apparatus. This frame design will allow a maximum height of 3 inches from the top of chassis frame to the top of the water tank.

The frame will be welded at 230-AMP minimum to allow excellent penetration and strength.

The main frame will be painted to prevent rust between the deck, crosslay and any other part of the structure before it is welded to the frame.

There will be four (4) mounting plates located on each corner of the fire bed which allows the bed to flex in rough terrain. The two (2) front mounting plates, one (1) per side, will be 6 inches x 12-inches (one on each side) and are made from 3/8-inch-thick

flat steel, welded to the 6-inch channel irons at the front of the apparatus. These plates use existing chassis frame mounting holes if available. The front mounting plates will be attached to the frame with two (2) 1/2-inch grade 8 bolts per plate.

The rear mounting plates will be attached to the frame with four (4)  $\frac{1}{2}$ -inch grade 8 bolts. The 9-inch x 10-inch rear mounting plates two (2) per side are made from  $\frac{3}{8}$ -inch flat steel and will be welded to the rear of the apparatus frame. These plates also weld to the rear bumper to provide superior strength and use existing holes in the chassis frame to secure the bed to apparatus.

#### **REAR BUMPER**

A custom fabricated, heavy-duty steel rear bumper will be made of 3-inch x 10-inch x 1/4-inch rectangular tubing. The rectangular tubing will be laid flat on the 10-inch side. This is coated with a bed liner product. A sheet of steel tread plate will be welded to the back edge of the tubing to enclose the area between the tubing and the underneath side of the bed. The bumper will extend 7" from the back of the boxes providing maximum protection to the rear of the apparatus. The bumper assembly will be mounted directly to the truck and bed frame and have a receiver attached to the tubing.

The bumper is equipped with four (4) flush mounted, red turn signal lights, and two (2) clear back up lights, completely sealed in a Lexan housing and lens. These lights will be cut into the bumper at a 45-degree angle, with 6-1/2-inch 90-degree centers. There will be three (3) flush-mounted rectangular mini-thin line sealed LED clearance lights completely sealed and waterproof mounted in a rubber grommet. The mini-thin sealed LED's will be installed in the center to indicate an 8-foot or wider vehicle, which meets DOT standards.

#### APPARATUS TRANSVERSE ROLL-OVER PROTECTION SYSTEM

Directly "aft" of the chassis' cab, the apparatus body shall have an integrated roll-over protection system which complies with side impact and crush standards of SAE International Surface Vehicle Standard SAE #J1194 for "Rollover Protective Structures for Wheeled Agricultural Tractors".

The roll-over protection structure shall be steel as required for compliance. Due to safety concerns for fire fighters, the structure must meet the above-mentioned standards without exception. The body manufacturer must list a minimum of ten (10) previously manufactured similar units presently in service that meet this standard. In addition, the bidder must submit both engineering drawings and digital photos of such installations.

Two (2) 79 inch high "fire attack operational areas" shall be installed, one (1) each side behind the cab as part of a "transverse walkway". The areas shall be used only while the apparatus is in actual "fire attack" or "on scene" operations. These areas are designed to allow standing while the vehicle is moving under 15 miles per hour. The occupants must be harnessed and belted during movement in these areas. The areas must not be used during transport mode or traveling to or from a fire scene. All occupants must be seated and belted within the cab during such modes.

The two (2) 79 inch high "fire attack operational areas" shall have a working area approximately 30 inches width (front to back) x 21.5 inches deep (left to right). This area also functions as steps and shall accommodate bunker-geared firefighters with transverse passageway to either side of the apparatus.

The two (2) 79 inch high "fire attack operational areas" on each side of the "transverse walkway" shall have floor areas constructed of 12 gauge pickled and oiled non-removable "Grip Strut" safety grating (#8 DIA 18.75" x 1.5"). Aluminum tread plate "kick panels" shall be installed on the vertical walls in these areas to minimize or avoid paint scratches. The vertical panels, when removed, shall allow access to the body mounting bolts.

A "pump control operational area" shall be installed between the two 79-inch-high areas as part of the "transverse walkway" behind the cab. This area does not meet the side impact and crush standards of SAE International Surface Vehicle Standard SAE #J1194 for Rollover Protective Structures and shall not be occupied while the apparatus is in motion. This area shall only be used when the apparatus is stationary in "fire attack" or "on scene" operations.

The "pump control operational area" shall have a working area of approximately 30-inch width (front to back) x 44-inch depth (left to right). The area is raised approximately 20 inches from the sidestep areas to allow 360-degree visibility. This area shall accommodate bunker-geared firefighters with access to the top mount pump control panel. All pump controls shall be in the top mount pump panel which shall be positioned such that it does not obstruct movement within the "transverse walkway".

The "pump control operational area" shall have a floor area constructed of 12 gauge pickled and oiled non-removable "Grip Strut" safety grating (#8 DIA 18.75" x 1.5").

Applicable warning placards shall be installed in each of the two (2) 79 inch high "fire attack operational areas" on each side of the "transverse walkway".

The forward-most roll-over protection structure assembly or "headache rack" directly behind the chassis cab shall be fabricated with an external framework of 2-inch x 11-

gauge continuous steel square tubing. The assembly shall have four (4) smooth hydraulically bent corners creating the 88 inches wide outside frame and forms a 42 inches wide x 19 inches high cab window frame. There will be two (2) oval LED work lights incorporated into the headache rack to light the ATROPS area as well as a handrail between the work lights. The rear sides of the work lights where the wiring runs will be protected by bright aluminum tread plate covers.

The internal frame of the "headache rack" shall be fabricated of 2 inches x 11-gauge square steel tubing. The "headache rack" assembly shall be welded to the apparatus steel substructure to meet the aforementioned side impact and crush standards of SAE International Surface Vehicle Standard SAE #J1194 for the "apparatus transverse rollover protection system". Aluminum shall not be an acceptable substitution for steel, as this feature requires a steel structure to meet the above-mentioned standards.

The lower portion of the "headache rack" shall be covered with .125-inch bright aluminum tread plate. This aluminum cover plate shall be one laser cut piece extended across the width of the "headache rack". This piece shall also function to cover the vertical surface inside the two (2) 79 inches high "fire attack operational areas". This cover plate shall be secured by stainless steel fasteners.

The rear-most roll-over protection structure assembly directly behind the "transverse walkway" shall be fabricated of 2 inches x 11-gauge square steel tubing. Two (2) "inverted u-shapes" on each side of the apparatus shall be tied together with a 2 inches x 11-gauge square steel tubing for pump control panel support. Two (2) 2 inches x 11-gauge square steel tubing units shall be installed on either side of the tank compartment; welded from the "inverted u-shapes" to the steel tread plate deck surface. In addition, two (2) 2 inches x 11-gauge square steel tubing units shall be welded to the outer-most support of the "inverted u-shapes" down to the floor of the 79 inches high "fire attack operational areas" on each side of the apparatus to support the "safety gates". The "inverted u-shapes" shall be welded directly to the apparatus steel substructure to meet the aforementioned side impact and crush standards of SAE International Surface Vehicle Standard SAE #J1194 for the "apparatus transverse roll-over protection system". Aluminum shall not be an acceptable substitution for steel, as this feature requires a steel structure to meet the afore-mentioned standards.

Two (2) 1.5 inches x 11-gauge steel tubing units shall be installed over each of the two (2) 79 inches high "fire attack operational areas". These tubes shall be angled from the top of the "headache rack" to the top of the rear-most roll-over protection structure assembly directly behind the "transverse walkway". These tubes shall be constructed in such a way that they do not obstruct motion from the two (2) 79 inches high step areas into the "pump control operational area". These tubes shall be required to meet the afore mentioned side impact and crush standards of SAE International Surface Vehicle

Standard SAE #J1194 for the "apparatus transverse roll-over protection system". Aluminum shall not be an acceptable substitution for steel, as this feature requires a steel structure to meet the afore-mentioned standards.

The lightbar mounting platform shall be constructed of steel tube and bolted directly to the headache rack with ample clearance from the top of the chassis cab. The mounting platform shall have a brush guard over the light bar integrated into the structure. The light bar mounting platform and light bar shall be removable with electrical connections of "plug and play" design.

## **RESTRAINT**

*Restraint* is a 4-point full body harness system. This allows a firefighter to operate within the ATROPS from a seated or standing position. The equipment includes: two sets of three retractors per side and one 4-point body harness.

The difference between being strapped into your seat by a standard car seatbelt vs. the *Restraint* is the mobility it provides to the firefighter. The *Restraint* acts like a seatbelt by letting you move normally, but when sudden unexpected movement occurs, the three retractors will lock into place restraining you from being thrown forward or upward. Whether you are in a seated or standing position, it will greatly reduce the possibility of being ejected from the fire apparatus.

# **Specifications**

This is a custom-built 4-point harness featuring four (4) inline adjusters to accommodate for a wide range of sizes, a chrome plated lift latch quick release buckle system, shoulder pads for comfort, three (3) "D" rings for easy "on & off" restraint capability and utilizing high visibility webbing for safety and ease of recognition.

The retraction system in the assembly makes use of covered automotive manufactured-quality web sensitive emergency locking retractors that release when you need extension, retract into their housing when not in use, and lock down as the webbing spools out quickly to keep you in place and safe.

#### PRE-CONNECTED CROSSLAY

A pre-connected crosslay hose bed will be lined with Superliner or equivalent to prevent chipping of paint, rust, and premature hose unloading. The 1-1/2-inch pre-connected crosslay hose bed is accessible from both driver and passenger sides as well as from the ATROPS crosswalk area. A swivel connection will allow the hose to be pulled free

without kinking at the connection. This crosslay is accessible from approximately 38-inches up from the ground.

The underneath side of the fire bed shall be coated with Corashield.

#### **SAFETY GATES**

Powder coated (Safety Yellow) inward swinging safety gates are installed on each side of the transverse walkway. The safety gates will have an opening not to exceed 200 square inches.

Each walkway gate shall have positive locking latches, capable of being operated with a gloved hand or booted foot.

Construction of the gates will consist of an outside rail (1-1/4-inch 11-gauge square tubing) with five (5) formed continuous bends creating an inward curved corner safety gate with three (3) 1-inch square 11-gauge cross tubes. The minimum height of the top bar of the gates is 52-inches. These gates are specifically designed to prevent outward swing in the event of latch failure or "gate stop" breakage.

The looped gate design allows for unobstructed use of the whipline. From the forward seated position in the crosswalk, the firefighter can remain harnessed and still fight fires across a large expanse of area. The spray pattern from this position can be 0-degrees to 120-degrees plus from either side of the walkway, depending on which side the firefighter is seated. A 120-degree pattern meaning that the nozzle can be aimed forward, shot through a 12-inch slot through the gate toward the chassis front, and moved continuously in a sweeping motion (120-degrees perpendicular).

Mud flaps will be mounted behind the rear dual wheels. A bracket that is incorporated into the bed of the fire apparatus will hold the mud flaps. The exhaust tailpipe will be moved to keep the mud flaps from burning.

# **RECESSED 325-GALLON TANK**

The tank will be 325-gallon capacity and is created by hand of polypropylene material that is several times stronger than standard polypropylene. The welds on the tank penetrate 100% throughout the thickness of the plastic sheet and are 16% stronger than the polypropylene sheet itself.

The tank will have a 6-inch-deep x 26-inch-long x 20-inch-wide drop sump in the front, not included in the 325 gallons, with a 3-inch drain in the tank bottom. The sump will allow 100% usage of water capacity of the tank with the pump at 120 GPM. NO EXCEPTION.

The tank shall have one (1) cross baffle and one (1) length baffle. The baffles will be securely attached to the top and bottom of the tank to form four (4) compartments. A fill tower of approximately 8-inch x 8-inch x 9 inch shall be located on the passenger side front corner. Other features include: a hinged lid on the fill tower, stainless steel strainer basket, anti-swirl plate, 3-inch suction fitting, suction tube to the sump, drain plug, removable lifting eye, and a limited lifetime warranty.

The tank will have a 3-inch suction and 1-inch top lid fill connection that is built into the tank.

The company that builds this tank has been 99.993% defect free in the last ten (10) years. If the tank does have a defect, the MANUFACTURER of the tank will personally come to your location within 48 hours (in the continental USA) to get the truck back in service.

#### **PUMP PANEL**

This pump panel has been CNC laser cut for accuracy, cleanliness, smoothness of the five lever slots, gauges, and controls. A 43-degree bend provides a more direct view for pump panel operation.

Two (2) shielded surface mount LED lights will provide illumination for pump panel operator. The top of the pump panel is equipped with a hinged lid and three (3) removable sides for easy access for service and maintenance of foam injection system

and controls. The finish will be GFH-620-W2 Mist Gray Wrinkle to cut down on light or sun reflection for the pump operator.

The pump control panel shall be mounted in the walkway area and have the following functions: start/stop switch, choke, pressure, and throttle control. If a foam system or CAFS option is chosen those controls and components are also in the pump panel.

#### **PLUMBING**

The control valves mounted in the panel are as follows: 1-1/2-inch pre-connect for crosslay, 1-inch tank fill, 1-inch hose reel and a 1-inch whip line. All the controls and functions are to be labeled.

All discharges shall originate from a square tubing manifold with a minimum of 3-inch x 1/4-inch-thick square tubing to prevent friction loss.

There shall be one (1) 2-1/2-inch quarter turn valve from the tank to the pump.

The suction line for drafting and hydrant use is to be 2-1/2-inches with a valve, suction adapter, 30-degree turn down, and chrome plug with chain. (There are a total of two (2) valves on the suction side of the pump.)

There shall be one (1) 2-1/2-inch quarter turn valve from pump to draft. With both valves open it shall function as a 2-1/2-inch quick fill.

A 1/4-inch full-time bypass line shall be installed to prevent pump overheating.

All stainless-steel plumbing shall be pressure tested to 200 PSI prior to installation.

#### **PUMP**

The pump shall be a Rowe RPM2/K19 EFI powered by a reliable state-of-the-art air-cooled Kohler 19-HP, overhead valve (OHV) electronic fuel injection engine. The engine has an electric start with a recoil backup to insure starting under all circumstances.

When possible, the pump will use fuel from the chassis fuel tank. This application will have an electric fuel pump installed. When not plumbed to the chassis fuel tank, there will be a fuel tank that holds 6 gallons of fuel.

The pump performance from the tank shall be 200 GPM @ 100 PSI, and 300 GPM @ 25 PSI. The pump will have a hand priming system as well as a 1/4-inch full time bypass

line installed to prevent pump overheating. The impeller is equipped with the following: a high strength corrosion resistant bronze (fully enclosed), double hubbed to balance hydraulic thrust, and mechanically balanced to eliminate vibration. The wear rings are long wearing bronze. They are easy to replace when required to restore original pump efficiency. The shaft sleeve is made of high strength stainless steel. The shaft seal is a spring-loaded mechanical type. The pump will have a 3-inch inlet and 2-1/2-inch discharge fitting.

There will be two (2) 500 Series Super LED strobes on the rear corners of the apparatus bed to meet NFPA standards.

The rear bumper is equipped with four (4) flush mounted, red LED turn signal lights, and two (2) clear LED back up lights, completely sealed in a Lexan housing and lens. These lights will be cut into tread plate bumper at a 45-degree angle, with 6-1/2-inch 90-degree centers. There will be three (3) flush-mounted rectangular mini-thin line sealed LED clearance lights completely sealed and waterproof mounted in a rubber grommet. The mini-thin sealed LED's will be installed in the center to indicate an 8-foot or wider vehicle, which meets DOT standards.

All electrical lines in the body will be protected by automatic circuit breakers, conveniently located to permit ease of service. Flashers, heavy solenoids, and other major electrical controls will be located in a central area near the circuit breakers.

All lines will be color-coded, or function coded every 3-inches. They are easy to identify, oversized for the intended loads, and installed in accordance with a detailed diagram.

Wiring will be carefully protected from weather elements and snagging. Heavy-duty loom will be used for the entire length.

To minimize the risk of heat damage, wires run in the engine compartment area will be carefully installed and suitably protected.

All electrical equipment will be installed to conform to the latest federal standards as outlined in NFPA 1901.

The bed will ground directly to the chassis frame using a ground strap fastened to a stainless-steel bolt that is welded to each frame. All electric components will in turn have a double or more ground termination. NO EXCEPTION.

guard option is chosen), center and rear on both sides of vehicle. Illuminated LED work lighting shall be installed in the walkway (in the headache rack) and pump area.

# **2 - UNDER ROLL BAR BOX COMPARTMENTS**

Under roll bar boxes are an excellent storage solution to the open flatbed design of the Chaparral. These tough, durable, sweep-out design boxes are made from 1/8-inch bright aluminum treadplate that creates a stylish finish. The compartment floors are to be covered with Turtle Tile style compartment matting. It consists of interlocking squares that are 12-inches x 12-inches x 3/4-inch thick.

The boxes are designed to be placed under the roll bars behind the crosslay and are easily accessible from the ground.

The boxes are single door design. They are a lap style door built with simplicity in mind. They are easily opened and latched with adjustable trigger latches. The trigger latches have a raised button design and chrome finish. There are four latches per door. Four latches provide good even pressure on the door seal. A 1/8-inch solid polished stainless-steel hinge is provided for durability and strength. The hinge is placed on the front side to avoid wind damage in case someone forgets to latch the door. A cable

restraint keeps the door from opening too far and avoids paint damage to the apparatus.

The body compartment measures 28-1/4-inches tall x 34-inches wide x 10-1/2-inches deep with an angled notch out of the top to accommodate for the angle of the roll bar. The width of the highest part of the compartment is 20-1/4-inches from the front to where it slops down to the back at a height of 16-1/4-inches. Each compartment has 5-1/4 cubic feet of storage space and can carry one (1) complete SCBA, one (1) spare bottle, flashlight, mask, and some hand tools.

## FRONT BUMPER/GRILLE GUARD

Unitized construction of the front bumper/grille guard will be fabricated with 2-inch square tubing x 3/16-inch wall thickness. Winch mounting brackets are 2-inch x 2-inch x 3/8-inch steel angle. The grille guard/light protection will be fabricated with 1-1/2- inch round 11-gauge steel tubing. Mandrel bends will be used in forming the bumper assembly. The completed bumper assembly will be powder coated textured black.

The front bumper/grille guard will accommodate an 8,000 lb. or 12,000 lb. winch.

The front bumper/grille guard (on a Ford Chassis) will be securely fastened to the truck frame with a minimum of 14 1/2-inch grade eight (8) zinc plated machine bolts.

3M Scotchlite reflective tape with 900 candlepower and 90-degree reflectivity will be applied to the bumper. (This tape complies with NHTSA and DOT-C2.) The bumper grille guard without winch will not exceed any more than 7-inches longer than the factory bumper.

Two (2) red 500 Series LED strobe lighting will be installed in bumper grille guard. The front bumper grille guard will have two (2) chrome tow hooks.

The front bumper/grille guard is designed not to break the pattern of the airflow to the chassis engine. All structural components are aligned with the construction of the chassis grille. This will not interfere with the chassis warranty.

To prove the strength of the front bumper grille guard, the builder of the guard will be able to lift the front of the chassis off the ground by attaching the front of the bumper grille guard at its weakest point to the very top of the outside edge of the grille guard without any structural damage occurring to the chassis or the grille guard. There will be pictures attached to prove this test. The manufacturer will keep OEM bumper.

#### **XTREME OFF ROAD KIT**

The Xtreme Off Road Package includes four (4) Founders M/T Radial 305/70R19.5 tires mounted on custom steel wheels; powder coated black. Tires and wheels shall be mounted and balanced.

The suspension is strengthened and raised 3 inches. The leveling kit consists of lift blocks, four (4) new shocks, upgraded U-bolts (from 3/4-inch to 7/8-inch), radius arm drop bracket, and extenda flares for fender wells. The front fenders are cut larger to accommodate the motion of the front wheels and rubber fender flares are added to the front fender molding.

# **SURFACE PREPARATION & CORROSION PREVENTION**

The steel superstructure will be sand blasted to remove any mill scaling and provide superior finish adhesion.

During fabrication, any bare steel not accessible after assembly, will have two coats of primer applied before assembly to control corrosion. All bare steel will be coated with the appropriate primer/sealer and polyurethane acrylic enamel, or equivalent finish to match the color of the chassis/cab provided.

Body assemblies that cannot be finish-painted AFTER assembly are to be finish-painted BEFORE assembly. Prior to applying primers and color finish, all removable items such as handrails, brackets, compartment doors, door hinges, trim, etc. shall be removed and painted separately to insure finished paint behind all mounted items.

The painted steel surface is easier to maintain than aluminum and gives a higher quality appearance. Once aluminum becomes dull it is extremely hard to restore its luster.

All dis-similar metals are protected with ECK corrosion protection.

The warranty will not apply to routine maintenance requirements as described in the service and operator's manual. 
claim is needed on an item not manufactured by Blanchat Mfg., Inc. it is advised to contact Blanchat Mfg., Inc. before contacting the warrantor.
