Vendor will provide a W9 form to the County Clerk.

The MVVFD nor Muskogee County will be responsible for any problems you may have in completing the work. Contractor will be responsible for any Insurance needed. Contractor will be accountable to the MVVFD Board of Directors only.

Please make sure terms and conditions are **Notarized**. Bids **MUST** be time stamped at the County Clerk's office.

Each Bid **MUST** be in a sealed envelope with the bid # on the outside of the envelope.

1. Sealed bids will be opened in the Commissioner's Conference Room, 400 W BROADWAY, SUITE 010  
MUSKOGEE, Oklahoma, at the time and date shown on the invitation to bid form.
2. Late bids will not be considered. Bids must be received in sealed envelopes (one to an envelope) with bid number and closing date written on the outside of the envelope.
3. Unit prices will be guaranteed correct by the bidder.
4. Firm prices will be F.O.B. destination.
5. Purchases by MUSKOGEE County, Oklahoma, are not subject to state or federal taxes.
6. This bid is submitted as a legal offer and any bid when accepted by the County constitutes a firm contract.
7. Oklahoma laws require each bidder submitting a bid to a county for goods or services to furnish a notarized sworn statement of non-collusion. A form is supplied below.
8. Bids will be firm until 3/17/2025 (Date) 9:00am
