

Thank you for allowing Sydaptic the opportunity to provide you with a quote to inspect, repair, or replace the detention locks and intercoms for the Muskegee County Jail. During my walk through I counted 77 detention doors that show the incorrect status, meaning they always show open or closed. We believe this is a limit switch adjustment, a wiring/cable issue, or the lock needs to be replaced. I believe the best way to determine the reason for these issues is to conduct a preventative maintenance walk-through for your facility. While onsite we will have replacement limit switches and 10 new detention locks for repairs. Reason for limiting replacement locks are the overall costs for each lock, \$3,276.00 each. Our preventative maintenance walk-through consists of the following:

- Applying correct lubricant to all moving parts inside locks
- Inspecting all parts for weak or broken parts
- Inspecting all fasteners to ensure all parts are secure
- Adjusting all limit switches
- Adjusting all hinges on all gate doors
- Replacing all parts that need it
- Removing all foreign debris placed by inmates
- Backing up of the control system log
- Trip Charge
- Time and Labor
- Hotel Charge
- Travel Expenses

While onsite Sydaptic will have 20 replacement intercoms should any need replacing and we will incorporate the utilities back into the security control system.

Estimated price for the proposed repairs are \$76,000.00.

NOTE: if any cable or wiring needs to be replaced, additional charges will be added to the total listed above. Prices are for 10 replacement locks and 20 intercoms. If the totals or either change, the price would be adjusted to reflect installed amount. This is a not to exceed quote. County will have all authorization of any changes to the total price.






