ORDER

AN ORDER AUTHORIZING THE CALLING AND HOLDING OF AN ELECTION IN MUSKOGEE COUNTY, STATE OF OKLAHOMA, FOR THE PURPOSE OF SUBMITTING TO THE REGISTERED VOTERS OF SAID COUNTY THE OUESTION OF THE ISSUANCE OF THE REGISTERED BONDS OF SAID COUNTY IN THE SUM OF TWENTY MILLION DOLLARS (\$20,000,000) TO PROVIDE FUNDS FOR THE PURPOSES OF ECONOMIC AND COMMUNITY DEVELOPMENT WITHIN OR NEAR MUSKOGEE COUNTY, INCLUDING JOB CREATION PROGRAMS, WITH OR WITHOUT THE USE OF OTHER FUNDS, LEVYING AND COLLECTING AN ANNUAL TAX, IN ADDITION TO ALL OTHER TAXES, UPON ALL THE TAXABLE PROPERTY IN SAID COUNTY SUFFICIENT TO PAY THE INTEREST AND PRINCIPAL ON SAID BONDS AS IT COMES DUE: PROVIDED HOWEVER. THAT IN NO EVENT SHALL THE REAL AND PERSONAL TAXABLE PROPERTY IN SAID COUNTY BE SUBJECT TO A SPECIAL TAX IN EXCESS OF FIVE MILLS ON THE DOLLAR FOR ALL BONDS ISSUED PURSUANT TO SECTION 35, ARTICLE X OF THE OKLAHOMA CONSTITUTION; PROVIDING FOR ELECTION PROCEDURES; AND CONTAINING OTHER PROVISIONS RELATING THERETO.

WHEREAS, it is deemed advisable by the Board of County Commissioners of Muskogee County, State of Oklahoma, to issue general obligation limited tax bonds to provide funds for economic and community development within or near Muskogee County, including job creation programs; and

WHEREAS, the estimated amount necessary for such purpose is TWENTY MILLION DOLLARS (\$20,000,000); and

WHEREAS, there are no funds in the treasury of Muskogee County, Oklahoma, for such purposes, and power is granted said County by Section 35, Article X of the Oklahoma Constitution and Title 62, Sections 801 *et seq.* of the Oklahoma Statutes, to issue such bonds to provide funds for such purposes, provided the same be authorized by the registered voters thereof, voting at an election held for that purpose.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF MUSKOGEE COUNTY, IN THE STATE OF OKLAHOMA:

SECTION 1.

That the Chairman of the Board of County Commissioners of Muskogee County, Oklahoma be, and he is hereby authorized and directed to call a special election to be held in said County on the 11th day of May, 2021, for the purpose of submitting to the registered voters thereof the following proposition:

PROPOSITION

COUNTY OF MUSKOGEE. STATE OKLAHOMA, INCUR AN INDEBTEDNESS BY ISSUING ITS BONDS IN THE SUM OF TWENTY MILLION DOLLARS (\$20,000,000) TO PROVIDE FUNDS FOR THE PURPOSES OF ECONOMIC AND COMMUNITY DEVELOPMENT WITHIN NEAR MUSKOGEE COUNTY, INCLUDING CREATION PROGRAMS, WITH OR WITHOUT THE USE OF OTHER FUNDS, AND LEVY AND COLLECT AN ANNUAL TAX, IN ADDITION TO ALL OTHER TAXES, UPON ALL THE TAXABLE PROPERTY IN SAID COUNTY SUFFICIENT TO PAY THE INTEREST ON SAID BONDS AS IT FALLS DUE. AND ALSO TO CONSTITUTE A SINKING FUND FOR THE PAYMENT OF THE PRINCIPAL THEREOF WHEN DUE, SAID BONDS TO BEAR INTEREST AT NOT TO EXCEED THE RATE OF FOURTEEN PERCENT (14%) PER ANNUM, OR THE MAXIMUM RATE ALLOWED BY LAW, PAYABLE SEMI-ANNUALLY AND TO BECOME DUE SERIALLY WITHIN THIRTY (30) YEARS FROM THEIR DATE; PROVIDED HOWEVER, THAT IN NO EVENT SHALL THE TAXABLE PROPERTY IN SAID COUNTY BE SUBJECT TO AN ANNUAL SPECIAL TAX IN EXCESS OF FIVE (5) MILLS ON THE DOLLAR FOR ALL BONDS ISSUED PURSUANT TO SECTION 35, ARTICLE X OF THE OKLAHOMA CONSTITUTION?

SECTION 2.

The specific projects for which at least ninety percent (90%) of the proceeds of the aforesaid bonds shall be expended, which may be accomplished through participation with other governmental agencies and others, and which may be accomplished in phases, shall be as follows:

PROJECT DESCRIPTION:

COSTS

The Economic and Community Development Projects for which the proceeds of the aforesaid \$20,000,000 Economic and Community Development Bonds shall be loaned, granted or expended shall be limited to qualified economic and community development purposes as defined in Title 62, Section 802 of the Oklahoma Statutes, as amended, to include job creation programs, and for the purpose of encouraging economic and community development within or near Muskogee County by providing loans, grants, other incentives or by County expenditures in furtherance of economic and community development, job creation and private investment in the community; for the expenses of implementation, administration and planning; and, for expenses of the bond issue. Guidelines will be established by the County which will assure accountability and adherence to sound economic and community development standards. Proceeds of the Economic and Community Development Bonds may be expended with or without the participation by other economic and community development agencies and entities.

the remainder to be used for the above specified projects, or other lawful purposes.

SECTION 3.

That such call for said election shall be by Proclamation and Notice of Election, signed by the Chairman of the Board of County Commissioners and attested by the County Clerk, with the seal of said County affixed thereto, and said Notice shall set forth the date and purpose of the election, the Proposition to be voted upon, the hours of opening and closing of the polls; that the voting machines or ballot used at such election shall set forth the Proposition to be voted upon substantially as set out in Section 1 hereof; and that the returns of said election shall be made to and canvassed by the Muskogee County Election Board.

SECTION 4.

The number and location of the polling places for said election shall be the same as the regular precinct polling places designated for statewide and local elections by the County Election Board. The persons who shall conduct the election shall be those precinct officers designated by the County Election Board, which officers shall also act as counters and certify the election results as required by law.
