The Eastern Oklahoma Development District (EODD) fiscal year begins on July 1<sup>st</sup>. and ends on June 30<sup>th</sup>., and FY2022 EODD memberships dues are now due. - Matching funds of approximately \$30,000.00 annually to Oklahoma Department of Human Services – Aging Services Unit to acquire funding for the Title III Nutrition Sites to provide congregate and home delivered meals to Seniors
- Matching funds of approximately \$ 30,000.00 annually to provide for the US Department of Commerce Economic Development Administration's planning grant
- Funding from membership dues supplement the Rural Fire Defense Program to which provides expertise technical advice and surplus excess Federal Property to the 102 volunteer fire departments in EODD's service area
- Supplemental funding for utilities and building maintenance and repairs
- Administering the -Rural Economic Action Program (REAP) for populations 7000 or less
- Community Expansion of Nutrition Assistance (CENA) sites for meals for Seniors
