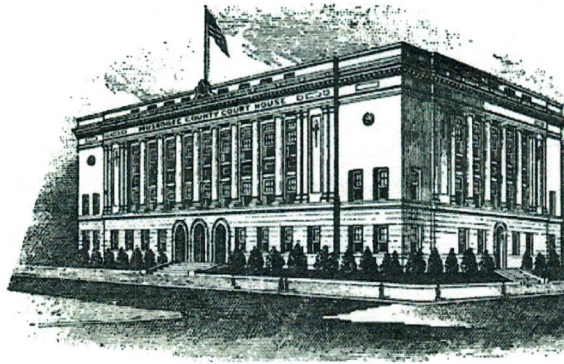

### **RESOLUTION**

**A RESOLUTION REVOKING THE DECLARATION OF EMERGENCY ESTABLISHED BY RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, AS AMENDED; WITHDRAWING JOINT CITY-COUNTY RESOLUTION NO. 2803; DISSOLVING THE JOINT CITY-COUNTY COVID-19 TASK FORCE; URGING CITIZENS TO FOLLOW ALL CURRENT AND FUTURE GUIDANCE ISSUED BY THE CENTERS FOR DISEASE CONTROL AND PREVENTION.**

**WHEREAS**, on May 3, 2021, Governor Kevin Stitt issued Executive Order No. 2021-11 which revoked Second Amended Executive Order No. 2021-07, effective May 4, 2021. The revocation lifted the State of Emergency for the State of Oklahoma which was previously declared due to the COVID-19 pandemic;

**WHEREAS**, Muskogee Board of County Commissioners finds that due to the low-rate of new infections and the wide availability of COVID-19 vaccines, it is in the best interest of its citizens to: 1) lift the County's declaration of Emergency set forth in a Resolution dated; 3/18/2020 and a COVID 19 Response Resolution dated; 3/18/2020; 2) Joint Resolution No. 2801, as Amended; 3) the County Resolution dated: 3/23/2020; 4) withdraw from the Joint City-County Resolution No. 2803 dated: 3/25/2020; and Amended Joint City-County Resolution No. 2803 dated 4/6/2020; 4) Joint Resolution No. 2809 dated 4/20/2020; 5) County Resolution dated 7/22/2020; 6) County Emergency Proclamation and Resolution dated 11/23/2020; 7) County Resolution dated 12/7/2020; 8) County Resolution dated 4/12/2021; 9) Dissolve the Joint City-County COVID-19 Task Force; and, 10) urge citizens to follow all current and future guidance from the Centers for Disease Control and Prevention ("CDC") in controlling the COVID-19 pandemic, including inoculation.

**NOW, THEREFORE, IT IS RESOLVED BY THE MUSKOGEE BOARD OF COUNTY COMMISSIONERS**, as follows:

1. The County's declaration of Emergency set forth in a Resolution dated; 3/18/2020 and a COVID 19 Response Resolution dated; 3/18/2020 is lifted.
2. Resolution No. 2801, as Amended is hereby revoked and the declaration of local emergency due to the COVID-19 pandemic is lifted.
3. The County Resolution dated: 3/23/2020 is lifted.
4. The City/County Joint Resolution No. 2809 dated 4/20/2020 is lifted.

5. The County Resolution dated 7/22/2020 is lifted.
6. The County Emergency Proclamation and Resolution dated 11/23/2020 is lifted.
7. The County Resolution dated 12/7/2020 is lifted.
8. The County Resolution dated 4/12/2021 is lifted.
9. Resolution No. 2803, as Amended is hereby revoked, withdrawing the  
County's participation in the Joint City-County Resolution.
10. The Joint City-County COVID-19 Task Force created by the City of Muskogee and the Muskogee Board of County Commissioners is hereby dissolved. The Chairman and Members of the Task Force are thanked for their service and issued commendation for their work, to wit:

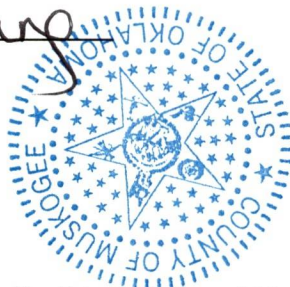
