

COMMUNITY SUPPORT GRANT AGREEMENT

This **AGREEMENT** (the "Agreement") dated this 6 day of June, 20 24, is entered into by and between the **Board of County Commissioners of Muskogee County** (the "County") and **1776 Fest, LLC** (the "Grantee") upon the following terms and conditions:

Section 1. Grant Awarded

The County shall award the Grantee a community support grant in the sum of Ten Thousand Dollars (\$10,000.00) (the "Grant") to promote, market, and enhance Muskogee County as a tourist destination in general and in support of Grantee's "Party Like its 1776" public fair event to be held in July 2024 (the "Event").

Section 2. Grantee Requirements

The Grantee shall list the County as a sponsor in any and all print and broadcast advertising media for the Event.

The Grantee must submit to the County a report within thirty (30) days of completing the Event detailing the activities of the Event in order to demonstrate a positive return on investment by the County.

Should the Event be cancelled due to inclement weather, the Grantee shall be required to return fifty percent (50%) of the Grant funds unless mutually agreed upon by the County and Grantee that a subsequent date will be held. Should the event be cancelled for any other reason, the Grantee shall be required to return one hundred percent (100%) of the Grant funds. In both cases, return of any disbursed funds shall take place within thirty (30) days of the cancellation date.

The Grantee shall keep records of invoices and statements showing proof of payment. At any time the County may deem necessary, the Grantee shall make available such records and documents, including but not limited to all contracts, records, invoices, materials, payrolls, personnel records, conditions of employment, and all documents relating to all matters covered by this Agreement. Under no circumstances will the County disburse more than the amount awarded for this Grant.

The Grantee will maintain insurance all required insurance associated with the Event. Grantee shall hold the County harmless from any and all liability associated with this Agreement.

Section 3. Independent Contractor

It is mutually understood and agreed that County and Grantee are at all times acting and performing as independent contractors. Grantee shall be solely responsible for obtaining and paying for unemployment compensation insurance and, worker's compensation insurance for Grantee and its agents and Grantee shall be solely responsible for any income, occupational, payroll, or other taxes, assessments, interest or penalty of any kind whatsoever assessed by any governmental agency or entity which may pertain to any monies earned, collected, paid or charged by or to Grantee pursuant to this Agreement. Grantee shall defend, indemnify and hold County harmless with respect thereto. In addition, Grantee shall not have any claim under this Agreement or otherwise against County for any unemployment compensation.

Grantee will exercise independent judgment and control over all activities and services rendered pursuant to this Agreement. Nothing in this Agreement shall be construed to give County any authority over Grantee's judgment or to direct the means or methods by which Grantee renders the services. Grantee will perform his duties in accordance with the appropriate standard of care for his profession and specialty.

Section 4. Miscellaneous

If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.

This Agreement constitute the sole and entire agreement of the parties to this Agreement with respect to the subject matter contained herein, and supersede all prior and contemporaneous understandings and

agreements, both written and oral, with respect to such subject matter. In the event of any inconsistency between the statement in the body of this Agreement and the documents to be delivered hereunder, the statements in the body of this Agreement will control.

This Agreement may only be amended, modified, or supplemented by an agreement in writing signed by each party hereto.

IN WITNESS WHEREOF, the parties have cause this Agreement to be executed as of the date written above by their respective officers thereunto duly authorized.


