1:

Motion was made by Commissioner Hyslop, approved to Open the meeting at 9:19 a.m. The motion was seconded by Commissioner Payne and was announced unanimously by Commissioner Doke.

2:

Motion was made by Commissioner Hyslop, approved all Purchase Orders. The motion was seconded by Commissioner Payne and was announced unanimously by Commissioner Doke.

3:

Motion was made by Commissioner Hyslop, approved all Monthly reports. The motion was seconded by Commissioner Payne and was announced unanimously by Commissioner Doke.

4:

Motion was made by Commissioner Payne, approved Regular meeting minutes for July 29, 2024. The motion was seconded by Commissioner Hyslop and was announced unanimously by Commissioner Doke.

Motion was made by Commissioner Payne, approved an Agreement between Muskogee County Fire Tax Board and Muskogee City County E911 Trust Authority for dispatch services of emergency and non-emergency calls from the public in the amount of \$79,999.92 for FY24-25 beginning on July 1, 2024 through June 30, 2025. The \$79,999.92 will be paid by the Fire Tax Board account (1321-2-8215-2005). The motion was seconded by Commissioner Hyslop and was announced unanimously by Commissioner Doke.

Motion was made by Commissioner Payne, approved a Corrective Quit Claim Deed for the recorded property owner of real property known as 2617 Arline St which was obtained in the Treasurers Resale, dated October 31, 2005 and recorded November 29, 2005. 14:


