Motion was made by Commissioner Hyslop and seconded by Commissioner Payne, approved to Open the meeting at 8:30 a.m. The motion was unanimous.

Motion was made by Commissioner Hyslop and seconded by Commissioner Payne, approved the Purchase Orders. The motion was unanimous.

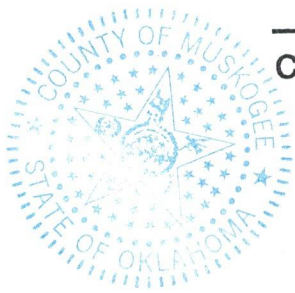
