The Muskogee Board of County Commissioners met in session at 8:15 a.m. Members present were: Chairman, Ken Doke; Vice-Chairman, Keith Hyslop; Member Kenny Payne; and Muskogee County Clerk, Polly Irving.

1: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved to Open the meeting at 8:44 a.m. The motion was unanimous.

2: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved the Purchase Orders. The motion was unanimous.

3: Motion

Commissioner Hyslop made a motion and it was seconded by Commissioner Payne, approved the Monthly reports. The motion was unanimous.

4: Motion

Commissioner Payne made a motion and it was seconded by Commissioner Hyslop, approved Regular meeting minutes for May 27, 2025. The motion was unanimous.

Motion was made by Commissioner Payne and it was seconded by Commissioner Hyslop, approved a Contract with Comanche County Juvenile Detention Center for the cost of \$60 per day per juvenile which is an increase from last FY of \$40 per day. The motion was unanimous.

Motion was made by Commissioner Payne and it was seconded by Commissioner Hyslop, approved a Lease Purchase Agreement Renewal #229686 from Security National Bank for a 2023 Mack Truck (1937) for District 1. The motion was unanimous.

Motion was made by Commissioner Hyslop and it was seconded by Commissioner Payne, approved a Contract between Eastern Oklahoma Youth Services and Muskogee County for the Pittsburg County Regional Juvenile Detention Center to house juveniles at a rate of \$38.97 per day per juvenile.
