WHEREAS the Organizer is hosting the Youth Leadership and Next Steps Summit (hereinafter referred to as the "Summit") on April 2nd in Muskogee, Oklahoma, the Speaker has agreed to participate in two breakout sessions.

NOW, THEREFORE, considering the mutual promises contained herein, the parties.

Agree as follows:

#### 1. Engagement of Services

The Organizer hereby engages the Speaker to participate in the Summits as a presenter of leadership.

#### 2. Date and Location

The Summit will be held on April 2<sup>nd</sup> at Muskogee High School Rougher Village, 3200 E. Shawnee Road, Muskogee, OK. 74403.

#### 3. Scope of Work

Two breakout sessions: The Speaker will present breakout sessions on the topic of Aeronautics, Leadership, and his journey to success. Each session will be the length of the breakout sessions duration and include [lecture, Q&A, panel participation, etc.]. The Speaker may provide materials such as slides or handouts at their discretion.

#### 4. Compensation

The Organizer agrees to pay the Speaker a speaking fee of \$2,500. Payment shall be made electronically within 30 days after the completion of the Summit.

## 5. Expenses

All expenses will be included in this agreement.

## 6. Cancellation

By Organizer: The Organizer may cancel this Agreement with no less than 14 days written notice to the Speaker. In the event of cancellation by the Organizer, any non-refundable expenses incurred by the Speaker shall be reimbursed.

By Speaker: The Speaker may cancel this Agreement with no less than 30 days written notice to the Organizer. In the event of cancellation by the Speaker, the Organizer shall not be liable for any payment beyond expenses already incurred.

## 7. Intellectual Property

The Speaker retains all rights to the materials and content presented at the Summit.

The Organizer may record up to fifteen (15) minutes of the Speaker's presentation for promotional use only. Complete recordings may not be used, sold, or distributed without the Speaker's written consent.

## 8. Confidentiality

Both parties agree to keep any sensitive or confidential information disclosed during the course of this Agreement private and not to disclose it to any third party without prior written consent.

## 9. Force Majeure

Neither party shall be liable for any failure to perform its obligations under this Agreement if such failure is due to circumstances beyond its reasonable control, including but not limited to acts of God, war, riot, epidemic, or governmental actions.

## 10. Limitation of Liability

The Speaker shall not be liable for any indirect, incidental, or consequential damages arising from participation in the Summit.

10. Governing Law  
This Agreement shall be governed by and construed in accordance with the laws of the State of Oklahoma.

11. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements or understandings, whether oral or written, relating to the subject matter hereof.

12. Amendments

This Agreement may only be amended in writing and signed by both parties.

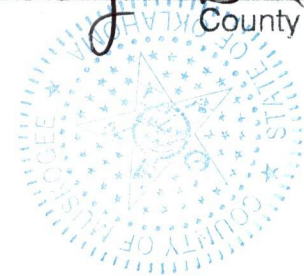
