Motion was made by Commissioner Hyslop and seconded by Commissioner Payne, approved to Open the meeting 9:04 a.m. The motion was unanimous.

Motion was made by Commissioner Hyslop and seconded by Commissioner Payne, approved all Purchase Orders. The motion was unanimous.
