

#### MEMORANDUM OF UNDERSTANDING

#### Between

#### **Muskogee County Detention Center**

#### And

# GREEN COUNTRY BEHAVIORAL HEALTH SERVICES (GCBHS)

This Memorandum of Understanding is hereby made and entered into by and between the Muskogee County Detention Center, hereinafter referred to as DETENTION CENTER. and Green Country Behavioral Health Services, Inc., hereinafter referred to as GCBHS. This MOU becomes effective upon signing and will remain in effect until either entity discontinues services.

### I. Purpose

This Memorandum of Understanding (MOU) represents a collaboration between the DETENTION CENTER and GCBHS for the purpose of providing services to individuals who are currently in custody at the DETENTION CENTER. This agreement does not supercede current law that does not enable the crisis unit to provide stabilization services for persons who are currently incarcerated.

### II. Background

GCBHS is contracted with ODMHSAS to provide behavioral health services to individuals in Muskogee and McIntosh Counties. Specifically, for this MOU, GCBHS is contracted to provide:

- Offender Screenings (ORAS)
- Competency Evaluations
- Jail Based Competency Services
- Crisis Screenings/Assessments

## III. Muskogee County Detention Center Responsibilities:

Collaborate with the GCBHS Staff regarding identified inmates and the care being provided to said inmates while in custody. The DETENTION CENTER will be provided with an agency issued iPad from which they will communicate with GCBHS to assess persons who are incarcerated and may be in need of services. The DETENTION CENTER will be responsible for keeping the iPads charged and will use them when necessary to communicate with GCBHS.



GCBHS will not provide crisis stabilization services for persons currently incarcerated Additionally, this MOU may be used to discuss inmates in the DETENTION CENTER who have been referred to GCBHS for the Jail-Based Competency Program.

# IV. GCBHS Responsibilities:

GCBHS will collaborate with DETENTION CENTER staff regarding individuals served while in the care of the DETENTION CENTER. Furthermore, GCBHS will provide education and resources related to GCBHS' services to DETENTION CENTER staff.

### V. Funding

This MOU does not include the exchange of funds between the two parties.

### VI. Termination

Either party may terminate this MOU for any reason by giving the other party thirty (30) days written notice of such intent to terminate. This MOU is at-will and may be modified by authorized officials of either party. This MOU becomes effective upon signature and will remain in effect until terminated by one of the partners.
