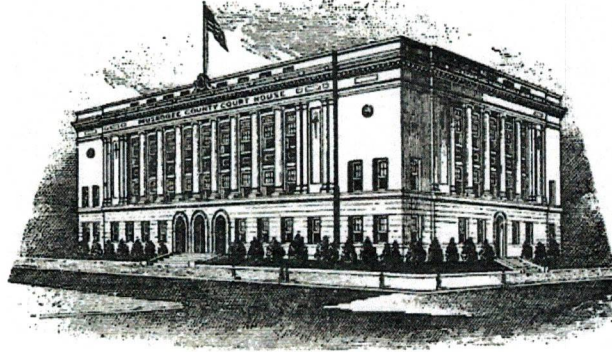

### RESOLUTION NO. 2024-03

**SUBJECT: Renaming of Porter Street in Boynton, OK to Jerry Belton Sr. Avenue**

**WHEREAS**, 69 OS § 628 gives the Board of County Commissioners exclusive jurisdiction of the designation of county highways;

**WHEREAS**, the Board of Trustees of the Town of Boynton, OK, passed a resolution authorizing and directing that certain street currently known as Porter Street between Miller Street and 8<sup>th</sup> Street in Boynton, OK, be renamed to "Jerry Benton Sr. Avenue."

**WHEREAS**, the Board of County Commissioners finds the renaming of the street to be warranted.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MUSKOGEE COUNTY AS FOLLOWS:**

**SECTION 1. POLICY.** The Board of County Commissioners does hereby accept the resolution adopted by the Board of Trustees of the Town of Boynton, OK, and hereby authorizes that certain street currently known as Porter Street between Miller Street and 8<sup>th</sup> Street in Boynton, OK, be renamed to "Jerry Benton Sr. Avenue."

**SECTION 2. IMPLEMENTATION.** All departments, officers, and employees of the county government shall take all appropriate measures within their authority to implement this resolution. Nothing in this resolution shall be construed to impair or otherwise affect the authority granted by law to a county department or officer. This resolution shall be implemented consistent with applicable law and subject to the availability of appropriations. This resolution is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against the county, its departments, officers, employees, or agents, or any other person.

**SECTION 3. REPEALER.** All other resolutions and parts of other resolutions inconsistent or conflicting with any part of this resolution are hereby repealed to the extent of such inconsistency or conflict.

**SECTION 4. SEVERABILITY.** If any provision, paragraph, word, section or article of this resolution is invalidated by any court of competent jurisdiction, the remaining provisions, paragraphs, words, sections and chapters shall not be affected and shall continue in full force and effect.

**SECTION 5. EFFECTIVE DATE.** This resolution shall take effect immediately upon execution and shall remain in effect until amended or repealed.

RESOLUTION NO 001-2024

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF BOYNTON, OKLAHOMA  
AUTHORIZING AND DIRECTING THE STREET NAME CHANGE OF PORTER STREET TO  
JERRY BELTON SR. AVENUE.

WHEREAS, the Town of Boynton (hereinafter referred to as the "Town") is a municipal corporation duly organized and existing pursuant to and under the provisions of the laws of the State of Oklahoma, and

WHEREAS, the Board of Trustees, by its statute authority, has previously approved the street name for Porter Street, and

WHEREAS, the Board of Trustees from time to time may determine that naming certain physical features of TheTown of Boynton after individuals, events, or business will provide a source of pride and community recognition, and

WHEREAS, Jerry Belton Sr. Avenue, is not in conflict with the public interests and welfare, and

WHEREAS, the change of such street name is warranted.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF TRUSTEES FOR THE TOWN OF BOYNTON, COUNTY OF MUSKOGEE, STATE OF OKLAHOMA, and THAT

Section 1. Porter Avenue between Miller and 8<sup>th</sup> Street shall be renamed as "Jerry Belton Sr. Avenue".

Section 2. The Town Clerk is hereby ordered to cause a certified copy of this Resolution, attested by the Town Clerk under the seal of the Town, to be recorded in the Office of the County Clerk of Muskogee County and to the Muskogee County Board of Commissioners.
