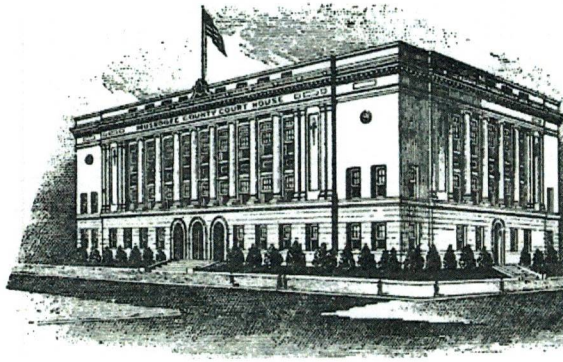

District 2 requires a change in the location for one of the culvert placements.

The location being replaced is E 233rd St S between S 125th St.

Identify the need or risk

During persistent weather events, water backup and the absence of proper drainage on S 55th St E between E 253rd St S and E 263rd St S; E 163rd St S between S 95th St E and S 105th St E; E 233rd St S between S 125th St E and S 105th St E; E 263rd St S between HWY 2 and S 75th St E; E 233rd St S between S 105th St E and S 95th St E causes flooding and significant damage to these roads. Ingress and egress for residents is affected and there is also risk to the availability of emergency services reaching residents in these areas, during these times.

How does the proposed expenditure respond to the need or risk?

The purchase of 4 tanker cars will give District 2 the ability to increase drainage. By cutting the cars in half, District 2 will be able to increase drainage at these locations thereby reducing flooding and mitigating further damage.




