

RESOLUTION

The Board of County Commissioners of Muskogee County, Oklahoma, pursuant to the
authority vested in the Board by Title 51, Section 10 of the Oklahoma Statutes, hereby
orders that a Special Election be held to fill the remainder of the term of Muskogee County
District Court Clerk. Robyn Boswell was appointed to the office of Court Clerk, which became
effective August 6, 2021 to fulfill the unexpired term at the retirement of Paula Sexton who
resigned July 31, 2021.

The filing period for the Special Election shall be April 13, 14, and 15, 2022; the Special Primary Election shall be held on June 28, 2022, the Special Runoff Primary Election shall be held on August 23, 2022; and the Special General Election shall be held on November 8, 2022.

The Secretary of the Muskogee County Election Board is hereby directed to take all actions necessary to conduct this election. A copy of this resolution shall be distributed to the Secretary of the Muskogee County Election Board.
