We are requesting the installation of closed circuit computer/camera system in Judge Robin Adair's courtroom. Judge Adair presides over the arraignment docket each day, which usually involves fifteen to thirty defendants, and their attorney and/or bondsman, in appearance. Judge Adair also handles every preliminary hearing on all felony matters, disposition dockets, mental health dockets, etc., all of which requires the defendant's appearance.
