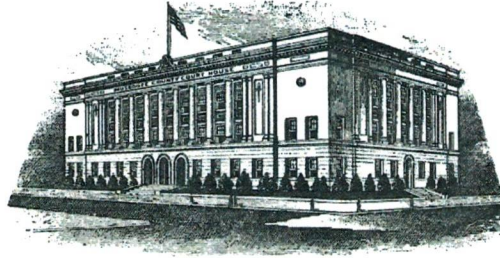

Dear Commissioners:

Please be advised that the term of Fred Hogle, a County appointee to the Muskogee City-County Port Authority (Port Authority) and the Muskogee City-County Trust Port Authority (Trust Authority), expires August 30, 2021.


Mr. Hogle is a tremendous asset to the Port Authority. He possesses a breadth and depth of knowledge about the Port of Muskogee and Three Forks Harbor that is invaluable. Identifying individuals that understand Port and Marina Operations and wants to volunteer their time to serve, is somewhat difficult in this day and time.

The Port Authority consists of 13 members; seven (7) represent Muskogee County, six (6) represent City of Muskogee; four (4) year terms. The Port Authority has full power and authority over all Port facilities within its jurisdiction; may purchase, construct, sell, or lease Port facilities and has the power to own, sell, lease, or operate property; provides traffic and rate information to shippers and shipping interests.

I would like to recommend, for your consideration, the reappointment of Mr. Hogle as a Member of the Board of the Muskogee City-County Port Authority and as a Trustee of the Muskogee City-County Trust Port Authority, to serve four-year terms, respectively through August 30, 2025.
