INTERLOCAL AGREEMENT

THIS AGREEMENT is made and entered into this __ day of January, 2022; by and between the Board of COUNTY Commissioners of Muskogee County, Oklahoma, hereinafter referred to as COUNTY, and the town of Oktaha, Oklahoma, herein referred to as OKTAHA. COUNTY and OKTAHA are collectively referred herein as the Parties.

WHEREAS Section 1008 of the Interlocal Cooperation Act, 74 Oklahoma Statutes Sections 1001-1008 (interlocal Act), permits public agencies to contract one with the other to perform governmental services, activities or undertakings which they are legally authorized to perform; and

WHEREAS COUNTY and OKTAHA share mutual interests in areas such as economic development, education, infrastructure, housing, healthcare, detention, food distribution, broadband, etc. within Muskogee COUNTY, Oklahoma; and in Oktaha.

WHEREAS COUNTY and OKTAHA share the same citizens; and

WHEREAS COUNTY and OKTAHA agree that a partnership between the Parties, as authorized in Section 1008 of the Interlocal Act, would provide the best opportunity for the pooling of resources for success; and

WHEREAS the governing bodies of COUNTY and OKTAHA wish to execute this agreement in order to facilitate said partnership.

NOW THEREFORE, COUNTY and OKTAHA do hereby agree as follows:

- 1. COUNTY and OKTAHA agree to partner to identify potential projects; seek outside funding sources; and make application with the intent of pooling resources in an effort to maximize funding for the best possible outcomes.
- 2. Upon receiving funding, COUNTY and OKTAHA agree to partner to provide any and all deliverables as required by the grant(s) or other funding sources.
- 3. COUNTY and OKTAHA may authorize arrangements with third-party entities, as needed, to facilitate this partnership.
- 4. COUNTY will assume the lead and facilitate all construction within the COUNTY right of way within the town of Oktaha. COUNTY agrees to front all costs, and OKTAHA agrees to reimburse COUNTY (with any grant funds received) for all allowable costs according to the specifics of the project scope, grant, and/or other funding source(s).
- 5. COUNTY and OKTAHA agree to approach projects as a partnership, and mutually agree to help facilitate the project(s) through positive engagement with the community;

assistance with any required right-of-way or easements; access to public property for construction staging; storage, etc.

IN WITNESS WHEREOF, this Agreement has been executed in multiple copies, each of which, for all purposes, shall be deemed an original and all of which shall evidence but one agreement between the Parties hereto, the day and year first above written.
