**MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding is hereby made and entered into by and between the Muskogee County Detention Center, hereinafter referred to as **DETENTION CENTER**, and Green Country Behavioral Health Services, Inc., hereinafter referred to as **GCBHS**. This MOU shall be effective upon the signatures of DETENTION CENTER and GCBHS officials and shall be in force from June 1, 2023 to June 30, 2025.

**A. Purpose:**

This Memorandum of Understanding (MOU) represents a collaboration between the DETENTION CENTER and GCBHS for the purpose of providing jail-based competency restoration services as defined by Oklahoma Department Of Mental Health and Substance Abuse Services (ODMHSAS) in the Jail-Based Project.

**B. Background:**

In December 2022, GCBHS obtained a contract modification from ODMHSAS with direction to work with the Oklahoma Forensic Center (OFC) in ensuring inmates who have been found not competent would be provided supportive services while in the DETENTION CENTER.

**C. Muskogee County Detention Center Responsibilities:**

Collaborate with the GCBHS Staff regarding identified inmates and the care being provided to said inmates while in custody. Additionally, this MOU may be used to discuss inmates in the DETENTION CENTER who have been referred to GCBHS for the Jail-Based Project.

**D. GCBHS Responsibilities:**

GCBHS will collaborate with DETENTION CENTER staff regarding individuals served while in the care of the DETENTION CENTER. Furthermore, GCBHS will provide education and resources related to GCBHS' services to DETENTION CENTER staff.

**E. Assurance of Confidentiality:**

GCBHS will obtain HIPAA compliant releases from individuals being served in this program to allow for collaboration and follow-up. The method of contact may be via Telehealth, by phone, or in person.


**F. FUNDING**

This MOU is at-will and may be modified by authorized officials of either party. This MOU becomes effective upon signature and will remain in effect until terminated by one of the partners.


