to the same be transferred by the Chairman of the Board of County Commissioners upon receipt of the above amount by the County Treasurer.

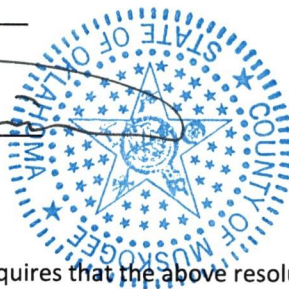
