CONTRACT

This contract is between Oktaha Public School ("School District"), and the Muskogee County Sheriff's Office (the "County").

RECITALS:

School District desires to contract with the county for the furnishing of law enforcement and school resource officer functions (the "Services") for School District campuses.

NOW THEREFORE, in consideration of the mutual covenants and agreements herein contained and intending to be legally bound, School District and the County agree as follows:

- 1. SERVICES TO BE PROVIDED BY THE COUNTY: The County agrees to provide one (1) properly certified, uniformed Deputy to perform the Services at School District locations and during the hours designated in this Contract. The County Deputy will work with School District personnel on a cooperative basis.
- 2. **TERM:** The term of this Contract will commence August 1st, 2022, and will terminate June 20th, 2023, or the last day of school. The contract may be renewed annually upon mutual agreement of the parties.
- 3. **COMPENSATION:** The County will be responsible for the salaries and fringe benefits of the Deputy, including appropriate deductions for taxes, FICA, and other amounts required by law.
- 4. FINANCING OF THE SCHOOL RESOURCE OFFICER PROGRAM:
 - For the fiscal year ending 2023, the financing of the Deputy will be as follows:

The Muskogee County Sheriff's Office will invoice Oktaha Public Schools \$3334.37 per month for the months that school is in session. The County will pay \$2700.00 per month to the Deputy.

- The Deputy will work a forty (40) hour shift each week, Monday through Friday, from approximately 7:30 am to 4:00 pm, or as needed, with one-half hour for lunch.
- The County reserves the right to immediately utilize the Deputy assigned to the School District in the event of a natural or

manmade disaster or emergency as part of the County's agency-wide response to said disaster or emergency. The County will notify School District as soon as it is reasonably able to do so about the temporary transfer of the Deputy to other duties. If such an emergency diversion of Deputies occurs then the School District as soon as it is reasonably able to do so about the temporary transfer of the Deputy to other duties. If such an emergency diversion of the Deputy occurs then the School District will not be required to pay the County for any portion of the diverted deputy's salary and benefits during the time of the diversions.

- 5. **TERMINATION:** The Contract may be terminated by either party by giving thirty (30) calendar days written notice to the other party.
- 6. **GOOD FAITH:** The School Board, the Sheriff, their agents and employees agree to cooperate in good faith in fulfilling the terms of this contract. Unforeseen difficulties of questions will be resolved by negotiation between the Superintendent of the School District and the County Sheriff.
