Vote: Motion was made by Commissioner Hyslop, to open the meeting. The motion was seconded by Commissioner Doke and was made unanimously by Commissioner Payne.

There were no documents presented to the BOCC to sign the approval. The motion was seconded by Commissioner Hyslop and was made unanimously by Commissioner Payne.

Vote: Motion was made by Commissioner Doke, approved the Quotes submitted from Smith Two-Way Radio (Fayetteville, AR) in the amount of \$28,587.35 and Muskogee Communications (Muskogee, OK) in the amount of \$29,732.50 for the installation of new transmittal equipment for Muskogee County Transit. Muskogee Communications was awarded the best of the two and will be paid utilizing ARPA Funds. A Contract of Agreement between Muskogee Communications and the BOCC will be submitted for review and signatures in the August 1, 2022 meeting. The motion was seconded by Commissioner Hyslop and was made unanimously by Commissioner Payne.
