MINUTES

The Muskogee County Fire Tax Board met in session at 7:00 p.m. Members present were: Chairman, Caleb Brewer; Vice-Chairman, Richard Naus; Treasurer, Bobby Allen; Sergeant at Arms 1, Jody Moore; Secretary, Polly Irving; Sergeant at Arms 2, Nathan Parker.

**1:**

The meeting was called to order at 7:00 p.m.

A motion was made by Oktaha and seconded by Mtn View, approved Treasurer’s Report: M&O account \$638,890.83 as of 01/20/2026, Capital Outlay account \$123,673.79 as of 01/20/2026. All in attendance were unanimous.

A motion was made by Taft and seconded by Oktaha, approving Regular meeting minutes for October 23, 2025. All in attendance were unanimous.
