REGULAR MEETING  
MINUTES

The Muskogee Board of County Commissioners met in session at 8:15 a.m. Members present were: Chairman, Keith Hyslop; Vice-Chairman, Kenny Payne; Member Ken Doke; and Muskogee County Clerk, Polly Irving.

**1: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved to Open the meeting at 8:37 a.m. The motion was unanimous.

**2: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved the Purchase Orders. The motion was unanimous.

**3: Motion**

Commissioner Doke made a motion and it was seconded by Commissioner Payne, approved the Monthly reports. The motion was unanimous.

**4: Motion**

Commissioner Payne made a motion and it was seconded by Commissioner Doke, approved Regular meeting minutes for January 12, 2026. The motion was unanimous.

So, I think there was a couple different prices, like they, if we kept it, it was one price that we let them." **Commissioner Payne:** "It's like \$1,500 difference is all it was." **Commissioner Doke:** "But last time you had a question there was something on the front and something on the back. Did we figure that out?" **BOCC Secretary Melissa Lee:** "There was an extra quote that they didn't need to add in the packet." **Commissioner Payne:** "They're mistake, not ours, not yours either." **Commissioner Doke:** "So, it's \$27,463, correct? And that'll go on the deductible. So, I guess the motion would be to approve that to be applied to the deductible and I'll make that as a motion." **Commissioner Payne:** And I'll second that motion." The motion was unanimous.
