The following is a list of the business to be conducted by the Board of Education at the above meeting:

1. Call Meeting to order.
2. Roll call.
3. Discussion and possible action to convene or not convene into executive session. Proposed Executive session pursuant to 25 O.S Section 307(B)(1) to discuss the following:
  - a. The Parent has the right to enter into Executive Session or Does the parent choose to remain in Open Session?
    - i. Parent chooses Executive Session.
    - ii. Parent chooses Open Session.
4. Student Suspension Due Process Appeal Hearing for Student "A".
  - a. Opening statement by administration or its designee
  - b. Opening Statement by parent/student or their designees.
  - c. Presentation of all administration's evidence subject to cross-examination and questions from the Board of Education.
  - d. Presentation of rebuttal evidence subject to cross-examination and questions from the Board of Education.
  - e. Closing Statements by parents/students or their designees.
  - f. Closing statements by administration or its designee.
5. Deliberation of the Board of Education. If not in executive session, the Board may vote at this time to enter into executive session pursuant to **OKLA. STAT.tit.25 § 307 (B) (7)** to discuss and deliberate on suspension of student "A" since disclosure of information would violate confidentiality requirements of state or federal law.
6. Motion, second and vote to acknowledge Board to return to open session.
  - a. Time entered into executive session, time exited.
  - b. Name those present and absent during the executive session;
  - c. All matters considered and that no other matters were discussed; and
  - d. The fact that no action was taken.



7. Motion and vote to adopt or not adopt findings of facts on the suspension of Student "A".
8. Motion and vote to affirm suspension or modify suspension (decrease severity of suspension) or overturn suspension of Student "A".
9. Motion to Adjourn.
