## INTERLOCAL AGREEMENT

This agreement for services ("Agreement" herein) is made and entered into the authority of 74 O.S. 1008 (Interlocal Cooperation Act) by and between the Sheriff of Muskogee County, Oklahoma and the Muskogee County Board of Commissioners, party of the first part, (Herein after called "Muskogee County") and McIntosh County Sheriff's Office (Herein after called "McIntosh County")

Whereas, Muskogee County has an excess of inmates who are being held in the Muskogee County Detention Center and has a need for inmate housing and McIntosh County has housing available for inmates at McIntosh County jail. Therefore, the purpose of this agreement is to enable Muskogee County to utilize county jail bed space at The Authority, to house prisoners sentenced to incarceration or awaiting sentencing.

Upon said approval, McIntosh County agrees to provide housing and board for inmates from Muskogee County.

In the event that there should be an unexpected medical expense, Muskogee County agrees to pay such expense.

Muskogee County agrees to pay McIntosh County at the rate of \$40 per inmate per day.

Muskogee County shall be responsible for all costs and expenses for transportation of inmates and medical treatment.

McIntosh County shall maintain a record of the number of Muskogee County inmates housed and the number of days per inmate per month.

McIntosh County will on the 1st day of each month (or reasonable time after) send an invoice to Muskogee County for services provided for the previous month.

This agreement shall remain in effect from March 15, 2026 to June 30, 2026.

This agreement may be terminated following oral or written discussion between the parties in which one of the parties wish to terminate the agreement or by the incapability of the holding facility at the McIntosh County Jail to continue to house inmates due to fire, flood, power failure, or other act of nature. In the event that either party wish to terminate the agreement, written notice shall be mailed, by certified mail, return receipt requested, or hand delivered to the other party. Who in turn will endorse the notice and have signature notarized and return to sender.

Muskogee County understands that all inmates transported to McIntosh County will conform to their rules and regulations.

McIntosh County will notify Muskogee County on major incidents involving Muskogee County prisoners.

From the date that the notice is received, Muskogee County will have 30 days to have any of their inmates in McIntosh County jail picked up and transferred to Muskogee County.

Muskogee County shall be responsible for paying daily cost of housing inmates up until the day they are moved from McIntosh County.






