NOTICE OF TORT CLAIM

TO: Muskogee County Board of Commissioners, Muskogee, Oklahoma.

DATE OF INCIDENT: July 23, 2023

On July 23, 2023, two officers of the Muskogee County Sheriff's Department INCIDENT: illegally entered the home, a motor home, of Mr. Gregory Gwyn which was parked off the roadway near 105th street and 273rd street in Porum, Muskogee County, Oklahoma. The Officers woke Mr. Gwyn who was resting due to heat exhaustion and loss of blood. Due to Mr. Gwyn's medical conditions, he was incoherent and unsteady on his feet. The Officers forcibly removed Mr. Gwyn from his home, and demanded that Mr. Gwyn be subjected to a field sobriety test. Due to his medical condition Mr. Gwyn was unable to perform the field sobriety test to the satisfaction of the Officers who then took Mr. Gwyn into custody, removed his belongings from his home and his person, and delivered Mr. Gwyn to the Muskogee County Jail. Mr. Gwyn was then subjected to an Intoxilyzer where he subsequently tested twice (2 times) and resulted in a 0.00 twice (2x). The Sheriff's department then took full custody of Mr. Gwyn and placed him in a jail cell. The Sheriff's Department failed to provide Mr. Gwyn with medical treatment despite having actual and constructive knowledge that Mr. Gwyn needed medical assistance. Mr. Gwyn was held in the Muskogee County Jail until he hired Counsel and Counsel contacted Judge Tucker who Ordered Mr. Gwyn's release. Mr. Gwyn was released from the Muskogee County Jail at approximately 1:00 p.m. on July 24, 2023. The Muskogee County Jail retained Mr. Gwyn's personal property until his Counsel sent a demand letter demanding the return of Mr. Gwyn's stolen property.

PLACE OF INCIDENT: Roadway near 105th street and 273rd street in Porum, Muskogee County, Oklahoma, Muskogee County Jail, Muskogee, Muskogee County, Oklahoma.

See above. Mr. Gwyn is seeking compensation for Wrongful Arrest, Conversion of Property, Damages from towing, towing expenses, False Imprisonment, Breaking and Entering a Dwelling by a police officer, Failure to Render aid to a prisoner with medical issues, and Burglary of a Dwelling.
