NOTICE OF TORT CLAIM & CIVIL AND U.S. CONSTITUTIONAL RIGHTS VIOLATIONS

Dear Ms. Boswell, On 9-7-23 I sent you an e mail which serves as notice of our tort claim against the City and County of Muskogee and the City of Fort Gibson requesting more information validating my acquittal of a felony arrest in case #'s 2016-83 &/or PC -407 &/or 2014 -98.

Those cases resulted in procuring a false arrest warrant for conviction of a felony for which I was acquitted. The arresting officer, Colby Langley, of the Fort Gibson Police, Muskogee County on 9-21-22, specifically stated "I was being arrested for a felony conviction" BASED ON DOCUMENTS [ARREST WARRANT], FOR ARREST SENT BY JUDGE ADAIR OF THE MUSKOGEE COUNTY DISTRICT COURTY. I went to your clerk's office on several occasions specifically requesting the information sent to the FORT GIBSON, police offices which caused my false arrest. Your office was not forthcoming with the information. In fact, I was told you would have to copy the whole file which at the time your office was not willing to do so, although I only asked for the information provided to police for an arrest. Hence, I am serving Notice of the Tort Claim dated 9-7-23 for false arrest, imprisonment and for my civil and U*.S. Constitutional Rights violations for a false felony conviction although appearing as a felony conviction as specifically stated by the arresting officer concerning the subject arrest. I have never been convicted of a felony. An arrest warrant ensued from Judge Adair for a felony causing me to be falsely arrested and imprisoned and further violating my Civil and U.S. Constitutional Rights.

My claim for false arrest and imprisonment and violation of my Civil and U.S. Constitutional Right is \$500,000.00

Hence, I would request that you remit this matter to the appropriate department/ insurance that handle such claims.

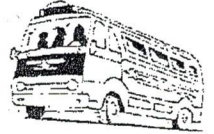
