On September 4, 2023, Hayden Pearce was operating a motor vehicle owned by Anna Barger near E. 253rd St. S. and S. 135th St. E. near Porum, Oklahoma in Muskogee County. At the time of the accident, Claimant, Jordan Cole, was a passenger in the subject vehicle, and Hayden Pearce was operating the vehicle as a permissive driver. A tree was lying on the road at approximately the intersection described above without being addressed by county/city/state officials. The county/city/state knew or should have known about the dangerous condition created by the fallen tree and failed to remove it, warn against it, or guard against it. A neighbor, Kimberly Alexander, observed the tree down on the road and called in to report that a tree had fallen but no one answered the phone and there was no option to leave a message. The vehicle in which Claimant was riding struck into the fallen tree causing the death of Hayden Pearce and bodily injury to Claimant, Jordan Cole, as well as property damage to the subject vehicle.
