





COMES NOW, Lisa R. Hickman, and petitions this Court under Title 60 of the Oklahoma Statutes (Oklahoma Trust Act) for a determination of the true legal character of the decedent's assets, establishment of proper jurisdiction, and correction of probate actions taken without authority. Petitioner alleges and states:

1. Assets Were Transferred Before Probate Was Filed

On June 30, 2014, several months before any probate petition was filed in Case PB-2014-157, two vehicles belonging to the decedent were transferred into the personal name of Denise Hickman.

These transfers did not occur through:

- a Transfer-on-Death designation,
- a Payable-on-Death designation,
- joint ownership,
- a will admitted to probate, or
- any court order.

Under Oklahoma law, a deceased person cannot transfer property except through a trust or other non-probate mechanism. The June 2014 transfers therefore indicate **trust assets**, not probate assets.

2. The Personal Representative's Attorney Admitted These Items Are Not Probate Property

On January 5, 2026, counsel for the Personal Representative filed a written statement acknowledging:

"Items transferred before probate are not subject to probate."

This admission establishes that the property at issue does **not** fall under Title 58 probate administration.

If the property is not subject to probate, the probate court lacks jurisdiction over it.

3. Probate Jurisdiction Cannot Attach to Non-Probate Assets

Subject-matter jurisdiction under **Title 58 (Probate Code)** applies only to **estate property**.

Property already transferred into another name **before** the filing of probate is not estate property.

Jurisdiction cannot be created by:

- assumption,
- implication,
- silence,
- passage of time,
- or the actions of any party.

If probate jurisdiction did not exist at the beginning, it cannot be retroactively created.

4. The Timeline Demonstrates This Matter Belongs Under Title 60

- 2013: Decedent passed away.
- June 30, 2014: Vehicles transferred into Denise Hickman's name.
- December 2014: Probate petition filed.
- April 2015: Inventory filed listing the same vehicles already transferred before probate.

This sequence shows that the assets were handled as **trust or non-probate property** before the probate proceeding began.

Such assets fall under **Title 60 (Trusts)**, not probate jurisdiction.

5. Relief Requested

Petitioner respectfully requests that this Court:

A. Determine jurisdiction under Title 60

Specifically declare that assets transferred prior to probate are **trust assets**, not probate assets.

B. Order full disclosure

Require disclosure of any trust documents, amendments, non-probate instruments, or related materials withheld from heirs.

C. Declare void any probate orders concerning non-probate property

As they were issued without subject-matter jurisdiction.

D. Require proper accounting and correction of records

Including correction of inventories and filings to reflect trust ownership.

E. Grant such other relief as the Court deems just and proper.


