

RESOLUTION NO. 2024-07

SUBJECT:

Intergovernmental Purchase between District 3 and Wainwright Fire

Department

WHEREAS, the County Central Purchasing Act (19 OS § 1500 *et seq.*) describes the process the County government must use for the purchase of goods and services for the operation of the County government;

WHEREAS, 19 OS §§ 1501(A)(3)(h) provides the ordinary competitive bidding requirements do not apply when the County government purchases equipment from a political subdivision of this State whereby authorized by 19 OS § 421.1.

WHEREAS, 19 OS § 421.1 allows the County government to enter into agreements with any tribal governmental entity, any other county, or any other political subdivision of this State for the purpose of selling, transferring, trading, or otherwise disposing of equipment without regard for the original cost of the equipment at issue.

WHEREAS, the Town of Wainright, by and through its Fire Department, wishes to transfer certain equipment to the County government for the benefit of the County Commissioner District 3 and the County government, by and through its Board of County Commissioners, does hereby consent to the same upon the terms and conditions contained herein.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MUSKOGEE COUNTY AS FOLLOWS:
